No New Users for Molina's Legacy Provider Portal Starting March 1, 2022

Molina Healthcare of Illinois (Molina) informs all providers that as of **March 1, 2022**, the Molina Legacy Provider Portal will no longer accept new user registrations. Additionally, later this year, Legacy Portal login will be disabled.

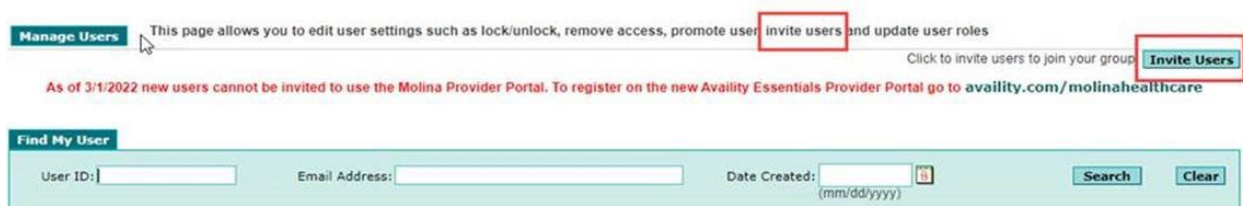
Important: We highly encourage providers to sign up for our Availity Provider Portal as soon as possible to avoid disruptions with your processes.

Providers and staff should register for the Availity Portal at the [Molina Healthcare/Availity Portal page](#). Going forward, you should only log in using the Availity Portal. Once registered, you and your staff will have **access to all portal functionalities**, plus you will enjoy these benefits:

- You save time, money, and work-hours by using the Availity Portal.
- Portal transactions are faster than the Legacy Portal, faxing, or calling Molina.
- Claims reach our Claims Processors more quickly, so the transactions are completed more quickly.
- PA requests reach us and are reviewed more quickly, which means more timely care for members.
- You can do business with multiple payers in Availity, increasing your staff's efficiency.
